\*\* Eligible repairs: repairs covered by the Basic Coverage of your New Vehicle Limited Warranty, repairs due to a Customer Satisfaction Program, recall or repair involving a LeaseCare covered component.

† PremiumCare Plans have a standard \$100 deductible, \$0, \$50, \$200 and "disappearing" deductibles available on all new vehicle plans.
